

PRIVACY STATEMENT CONSIGLIO CORPORATE DEVELOPMENT BV IN ROTTERDAM

Consiglio Corporate Development BV attaches great importance to the protection of your personal data. In this privacy statement we wish to provide clear and transparent information about how we handle personal data.

We make every effort to ensure your privacy and therefore handle personal data with care. Consiglio Corporate Development BV complies in all cases with applicable laws and regulations, including the General Data Protection Regulation (AVG).

This implies that we at least:

Processing of personal data

Personal data are processed by Consiglio Corporate Development BV for the following purpose (s):

- executing or issuing an assignment;

The basis for this personal information is:

- the agreed assignment

For the purpose (s) above, Consiglio Corporate Development BV may request the following personal data from you:

- First and last name;
- job title;
- address data;
- sex;
- date of birth;
- phone number;
- e-mail address;
- passport number;
- VAT number
- other information regarding your company before entering into an assignment.

We retain your data insofar as this is necessary for the realization of the purposes for which we process your data and for no longer than legally permitted in any case during the term of your assignment.

Provision to third parties

We may provide the information you give to us to third parties if this is necessary for the execution of the above described purposes.

For example, we use a third party for:

- maintenance of the internet environment;
- taking care of the (financial) administration.

We never pass on personal data to other parties with whom we have not entered into an agreement to process the data. With these parties we obviously make the necessary arrangements to ensure the security of your personal data. Furthermore, we will not provide the information you provide to other parties, unless this is legally required and permitted.

We may also share personal data with third parties if you give us permission in writing.

Within the EU

We do not provide personal data to parties which are located outside the EU.

Storage period

Consiglio Corporate Development BV does not store personal data longer than is necessary for the purpose for which it was provided or is required by law.

Security

Consiglio Corporate Development BV takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification. The website of Consiglio Corporate Development BV uses a reliable SSL Certificate to ensure that your personal data is not in the wrong hands.
